**Acquisition of computer equipment for the Directorate General of Budget**

The **Ministry of Finance and Budget** has secured funds under the State investment budget, financial year 2019, and intends to use part of these funds to make payments under the contract **N0. F-AON-003/MFB/CAB/CGMP-2019**.

**The Ministry of Finance and Budget** requests bids under sealed from eligible bidders and who meet the qualifications required to provide **computer equipment for the Directorate General of Budget in three (3) lots:**

**Lot 1: 200 Desktop computers;**

**Lot 2: 50 Black and white laser printers;**

**Lot 3: 20 Black colour laser network printers.**

Each lot is the subject of a separate contract.

The procurement will be conducted through open invitation to tender without pre-qualification as defined in the Code of Public Contracts, and open to all eligible bidders.
